



MODEL RELEASE

I, _____ (“Model”), in consideration of my engagement as a model and for other good and valuable consideration, the receipt and sufficiency which are hereby acknowledged, hereby agree with FILMPAC, LLC (“Producer”), as follows:

1. In this release: (a) “Producer” includes the Producer’s affiliated companies, legal representatives, successors, assigns, licensees, subcontractors, and agents; and (b) my “Image” includes my voice, likeness, appearance, name, age, sex, ethnicity, other personal attributes, and any personal property I may have brought with me to the photo shoot, however, wherever, and whenever captured using any Media.

2. The Producer has the unrestricted right to photograph, sound record, film, or otherwise capture my Image, using any technology or media including, but not limited to, digital, electronic, print, television, and film, now known, or hereafter invented (collectively, “Media”).

3. My Image may be edited, stored, modified, reproduced, copied, and otherwise used, and reused, at the sole discretion of the Producer throughout the world for any purpose whatsoever, including, but not limited to, publication or distribution on any website or in any publication, video, or film, for commercial or non-commercial purposes, without restriction, as an intermediary product or a finished product. For the avoidance of doubt, the Producer may make my Image available on any Media for resale to third parties for reproduction and/or distribution by that third party in any medium throughout the world.

4. Any and all aspects of my Image may be blurred or distorted or altered in any manner, and I waive any right to inspect or approve the intermediary product(s) or the finished product(s) that may include my Image. The undersigned hereby releases, discharges, and agrees to save harmless Producer and its legal representatives, and assigns, and all persons acting under his/her permission or authority, or those for whom he/she is acting, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, even though it may subject me to ridicule, scandal, reproach, scorn, and indignity.

5. The rights granted by me hereunder are granted for the entire universe, are irrevocable, and shall inure in perpetuity.

6. This release is governed by the laws of the State of Oregon, USA.

7. I hereby consent to the use of my Image as described in this release without any further compensation to me, and I acknowledge that nothing in this release shall be deemed to obligate the Producer to use my Image on any Media for any commercial or non-commercial purpose or otherwise make use of any of the rights granted by me to Producer herein.

8. I represent and warrant that: (a) I am of legal age; (b) I can legally enter into this release; and (c) I can sign this release without breach of any prior agreements or applicable law. I further represent and warrant that this modeling engagement and the use of my Image will not result in any obligation on behalf of Producer or any third party to pay royalties or other fees to any guild, association, union or other form of collective rights society.

9. I release, discharge, and agree to hold Producer harmless from any and all claims, demands or other liability (“Losses”) that may be incurred by Producer or any third party as a result of, or otherwise arising out of, the use of my Image in any Media, including, but not limited to, any claim by me or anyone else.

10. I further release, discharge, and agree to hold Producer harmless from any and all Losses that may arise, whether incurred by me or anyone else, as a result of Producer’s own negligence in connection with my participation as a Model, including, but not limited to, property damage, personal injury, or death.
